Sunshine: We wish Daryl Eggleston a quick recovery from his gall bladder surgery.

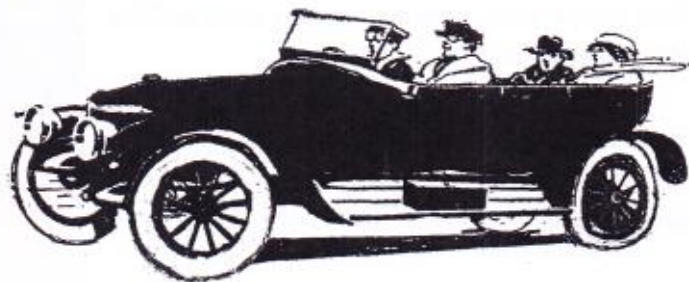
Membership: Nothing to report.

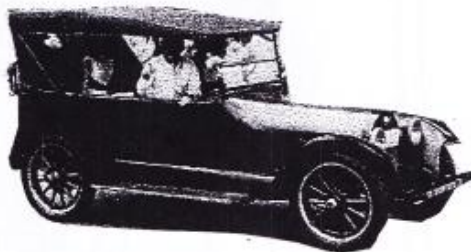

AB49 (Buchanan D) License plates: breast cancer awareness. (Introduced: 12/21/2012)

Summary: Would authorize the DMV, in consultation with the State Department of Health Care Services, to design and make available for issuance special breast cancer awareness license plates bearing a full-plate graphic design depicting a the pink breast cancer awareness ribbon on a pink background, as specified, upon payment of an additional fee by a person applying for the special plate. The bill would require the revenue generated from the license plates, as specified, to be deposited in the Breast Cancer Awareness Account, which is created by the bill in the Specialized License Plate Fund, for use by the State Department of Health Services, upon appropriation by the Legislature, for providing free or reduced-cost breast cancer preventative treatments, or funding research for treatments and cures for breast cancer.

AB64 (Donnelly R) Vehicles: recreational off-highway vehicles. (Introduced: 1/7/2013)

Summary: Existing law establishes rules for the operation of off-highway vehicles, including specified requirements governing the operation of recreational off-highway vehicles. This bill would repeal all provisions applicable to the operation of recreational off-highway vehicles.

AB168 (Wilk R) Local government finance: vehicle license fee revenues: allocations)

Summary: Under existing law, the Controller is required to allocate vehicle license fee revenues in the Motor Vehicle License Fee Account according to a specified order, with moneys allocated on or after July 1, 2004, but before July 1, 2011, first to the County of Orange, next to each city and county meeting specified criteria, and on or after July 1, 2011, to the Local Law Enforcement Services Account in the Local Revenue Fund, for allocation to cities, counties, and cities and counties. This bill would make technical, nonsubstantive changes to these provisions.

AB 220(Ting D) Vehicles: low emissions: financial incentives. (Introduced: 2/4/2013 [pdf](#) [html](#))

Summary: Would state the intent of the Legislature to enact legislation to develop and implement a policy consisting of financial incentives to promote the purchase of certain low-emission vehicles.

AB266(Blumenfield D) Vehicles: high-occupancy vehicle lanes

Summary: Would extend the operation of provisions relating to HOV lane use to January 1, 2025, or until the Secretary of State receives a specified notice, by certain low-emission, hybrid, or alternative fuel vehicles not carrying the requisite number of passengers otherwise required for the use of an HOV

lane, if the vehicle displays a valid identifier issued by the Department of Motor Vehicles. This bill contains other related provisions and other existing

AB281 (Donnelly R) Vehicle registration: late penalties: waiver. (Introduced: 2/11/2013 [pdf](#) [html](#))

Summary: Would require the Department of Motor Vehicles to waive delinquent registration fees and penalties when a transferee or purchaser of a vehicle applies for a transfer of registration if the department determines that the fees became due or the penalties accrued prior to the purchase of the vehicle.

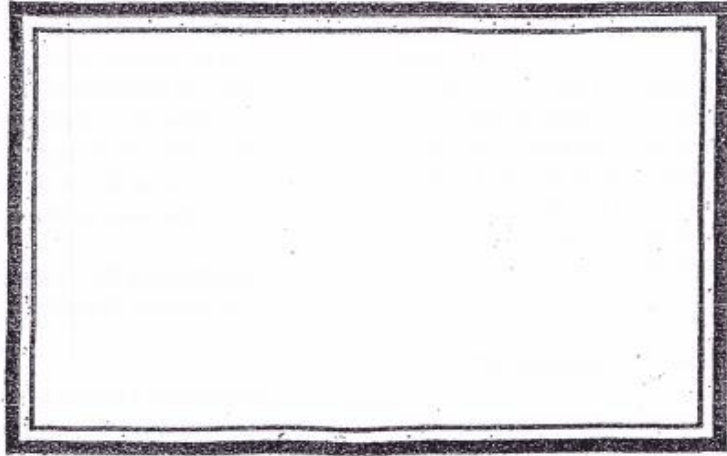
AB298 (Pan D) Vehicles: license plates. (Introduced: 2/12/2013 [pdf](#) [html](#))

Summary: Current law, subject to exceptions, requires the Department of Motor Vehicles to, upon registering a vehicle, issue the owner 2 partially or fully reflectorized license plates. Current law also authorizes the department to issue a variety of specialty license plates, as specified This bill would express the intent of the Legislature to enact legislation authorizing the issuance of an agriculture license plate.

AB335 (Brown D) Vehicles: impoundment.

Summary: Current law authorizes a peace officer who determines that a person was driving a vehicle while his or her driving privilege was suspended or revoked, driving in violation of a driver's license restriction requiring that person to operate a vehicle that is equipped with a functioning, certified ignition interlock device, or driving a vehicle without ever having been issued a driver's license, to either immediately arrest that person and cause the removal and seizure of that vehicle or, if the vehicle is involved in a traffic collision, cause the removal and seizure of the vehicle without the necessity of arresting the person. This bill would prohibit a peace officer from impounding the vehicle if the vehicle could be or is legally parked at a location near the traffic stop, if control of the vehicle is relinquished to a licensed driver who is present and authorized by the driver to take the vehicle, or if a licensed driver retrieves the vehicle within a reasonable time. This bill contains other related provisions and other existing laws.

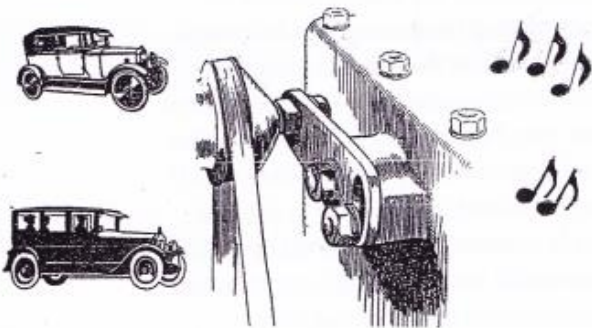

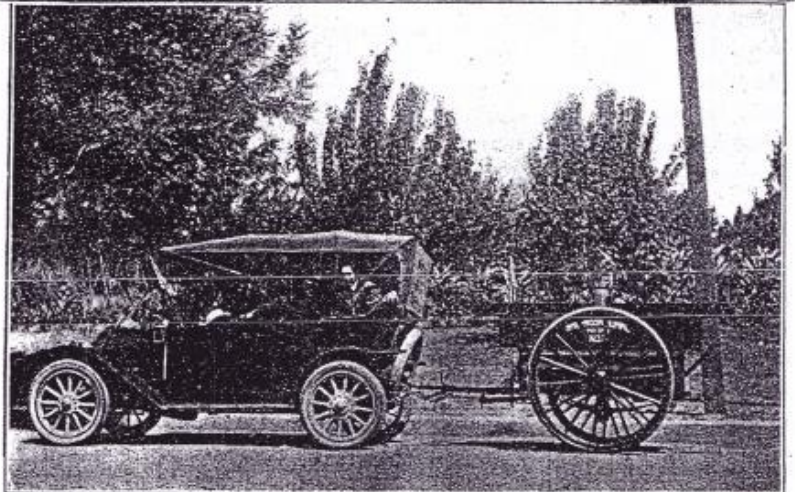
